Tristan Boyd, Ashley Stewart Boyd, and/or The Fantasy Love Co. reserves the right to include any future-developed intellectual property, trademarks, or copyrighted materials under the scope of this agreement. Practitioners agree to comply with updated terms and acknowledge that new methodologies, tools, or frameworks introduced by The Fantasy Love Co. may require additional training or licensing fees, which will be communicated in advance. Practitioners further agree to respect and maintain the confidentiality and proprietary nature of such additions.

2. Definition of Methodology:

4. Grant of License:

2. Consideration

Now therefore, in consideration of the mutual covenants contained herein, and for other good and valuable consideration, the sufficiency of which is hereby acknowledged by the Parties, IT IS AGREED AS FOLLOWS:

3. Terms and Conditions

1. Grant of License and Rights

Scope of License

The Fantasy Love Co. (“Licensor”) grants the Licensee a **limited, non-exclusive, non-transferable, non-sublicensable license** to utilize the proprietary **Be Who You Really See™ Methodology** under the Licensed Practitioner Program. c. Authorized Use of Be Who You Really See™ Methodology and all The Fantasy Love Co. Materials and Practitioner Rights

Practitioners who have successfully completed mandatory training and met all associated requirements under **The Fantasy Love Co.’s Licensed Practitioner Program** are granted the following rights and agree to the authorized use of **Be Who You Really See™** materials, tools, and exercises exclusively for **paying clients** as outlined below.

Practitioners are permitted to:

- Apply the methodology to their own life.
- Coach **paying clients** in individual or group settings using the methodology.
- Deliver workshops, programs, or courses aligned with the methodology **exclusively for paying clients.**

- **The Secrets to A Level 10 Love Life™ Training**: Empowering clients by teaching them The 3 Secrets to Create A Level 10 Love Life, which are the strategies to elevate their essence, master magnetic attraction, and calculate the real cost of not having the love life they imagine.
- **Create Your Fantasy Love Story™ Training**: A structured program guiding clients to Master The Secrets to A Level 10 Love Life.
- **Love Reimagined™ Training**: A transformational coaching journey helping clients deepen emotional and magnetic connections in their relationships.
- **Be Who You Really See™ Training**: Focusing on self-discovery, authenticity, and unlocking one's full potential for personal and relational fulfillment.

2. Teach and Facilitate: Practitioners are authorized to:

- Use proprietary tools, teachings, and principles to empower individuals and groups to embrace their true selves, transform their lives, and design relationships aligned with their deepest aspirations.
- Share all proprietary materials, tools, and exercises **exclusively with paying clients** as part of licensed coaching engagements.

3. Deliver Structured Programs: Practitioners may conduct structured programs, workshops, or coaching sessions for paying clients, including:

- One-on-one coaching engagements tailored to individual client needs.



The following actions or omissions shall constitute a material breach of this Agreement and the limited license provided herein. Such breaches may result in immediate termination of the license and associated rights:

a. Impairing or Prejudicing the Integrity of the Licensed Property:

Engaging in actions that damage or compromise the integrity of the **Be Who You Really See™ Methodology** or its associated tools, materials, or reputation.



b. Unauthorized Alteration of Licensed Materials:

Superimposing, inserting, merging, or altering any part of the **Be Who You Really See™ Methodology** proprietary materials, including but not limited to:

Displaying any video clips or recorded materials from the methodology in isolation, for any unauthorized purpose, or outside the intended coaching context with paying clients.

d. Offensive or Inappropriate Use of Licensed Property:

Using licensed materials in a manner that is scandalous, derogatory, offensive, defamatory, obscene, immoral, racial, controversial, or pornographic. No portion of the proprietary content, no matter how small, may be combined with other marks, images, or artwork to create new impressions that fall within these categories.

e. Misrepresentation of Terminology:

Using any term other than **Be Who You Really See™** to describe the methodology or associated work. Practitioners may not misrepresent their qualifications or status, nor advertise materials or trainings under misleading terms such as "certified training," "train-the-trainer programs," or "official certification."

f. Unauthorized Reproduction of Licensed Property:

Reproducing or copying licensed materials in any medium without explicit written authorization. This includes, but is not limited to:

Enforcement of Rights

Breaches outlined above may result in:

1. Immediate termination of the Practitioner's license and revocation of rights to use the **Be Who You Really See™ Methodology**.
2. Legal action for damages, including intellectual property infringement.
3. Suspension or permanent revocation of access to proprietary tools, materials, and resources provided by **The Fantasy Love Co.**



7. Indemnification

Practitioner agrees to defend, indemnify, and hold harmless **The Fantasy Love Co.**, its owners, employees, agents, and affiliates from any and all damages, expenses, or liability resulting from or arising out of the Practitioner's:

9. Attorney Fees and Costs

- Other expenses incurred during the prosecution or defense of the matter.

10. Survival of Terms

All terms, conditions, and obligations of the parties that remain unsatisfied or unperformed at the termination of this Agreement shall survive its termination. This includes, but is not limited to:

- Confidentiality obligations.
- Intellectual property rights.
- Indemnification clauses.



11. Relationship of Parties

The Practitioner is an independent contractor and shall not be considered an employee, partner, joint venturer, or agent of **The Fantasy Love Co.** Nothing in this Agreement shall be construed to create such a relationship.

The Practitioner has no authority to act on behalf of or bind **The Fantasy Love Co.** in any capacity beyond the rights explicitly granted under this Agreement.

12. Joint Effort

This Agreement has been prepared as a collaborative effort between the parties. As such, it shall not be construed more severely against one party than the other in the event of a dispute regarding its terms or interpretation.

13. Representations and Warranties of Parties

Each party represents and warrants that:

1. They have the legal right and authority to enter into this Agreement.
2. They have read, understood, and agreed to abide by all terms of this Agreement.

14. Miscellaneous

a. Notices

The parties may, by written notice, designate other addresses for the receipt of notices under this Agreement.

b. Applicable Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas, without regard to its conflict of laws principles. The parties agree that all causes of action arising under or related to this Agreement shall be brought exclusively in the courts of Dallas County, Texas.



c. Entire Agreement

This Agreement supersedes all prior agreements, representations, negotiations, or other understandings between the parties regarding its subject matter. No amendments or alterations shall be valid unless made in writing and signed by authorized representatives of both parties.

d. Force Majeure

Neither party shall be held liable for any delay or failure to perform its obligations under this Agreement due to events beyond its reasonable control, including but not limited to acts of God, governmental actions, labor disputes, or other unforeseen events. Performance shall resume as soon as reasonably possible after such events have been resolved, provided that the affected party exercises due diligence.

e. Warranty Disclaimers

The Fantasy Love Co. makes no warranties, express or implied, including but not limited to implied warranties of merchantability, fitness for a particular purpose, title, or non-infringement with respect to any materials or services provided under this Agreement. The Practitioner assumes all risks related to the use of materials and services provided under this Agreement.

f. Exclusion of Certain Damages

Neither party shall be liable for indirect, consequential, special, incidental, or punitive damages related to this Agreement, even if advised of the possibility of such damages in advance. This exclusion does not apply to claims involving intellectual property infringement, breaches of confidentiality, or unauthorized use of proprietary materials.

g. Dispute Resolution

The parties agree to resolve any disputes arising from or related to this Agreement as follows:

1. **Mediation:** Submit the dispute to a neutral, qualified mediator for resolution.
2. **Arbitration:** If mediation fails, unresolved disputes shall be decided through binding arbitration, with the mediator serving as the arbitrator.
3. **Costs:** The non-prevailing party shall pay all reasonable attorney fees, mediator/arbitrator fees, and associated costs incurred by the prevailing party.

h. Assignment

This Agreement and the rights and obligations herein may not be assigned or transferred by the Practitioner without prior written consent from **The Fantasy Love Co.** **The Fantasy Love Co.** retains the right to assign this Agreement to any successor in interest without prior notice.
